The Land Revenue & Disaster Management Department invites application in the prescribed form from eligible in- service Revenue Surveyors candidates for filling up of the following vacancies through Limited Departmental Promotion Examination:

1. SCHEME OF THE EXAMINATION:

The examination for the post shown above will consist of one paper as under:

All questions shall be of 'Multiple Choice Question (MCQ)' type carrying 2 marks each. There shall be **no negative marking**.

The candidates securing minimum qualifying marks shall be considered for next round of selection process, i.e., ACR evaluation. Merit list will be drawn on the basis of cumulative score. Based on the number of vacancies available, corresponding number of candidates in order of merit shall be declared qualified.

The score for ACR evaluation will be determined as under:

An aggregate of score for preceding four years will be taken as the final score.

2. SYLLABUS

- I. The syllabus for the Limited Departmental Promotion Examination for promotion to the post of **Head Surveyor** is as under:

- (i) History of Sikkim with focus on land reforms, Acts and old land laws of Sikkim.
- (ii) Revenue Administration.
- (iii) Land Acquisition (New Act).

3. DOCUMENTS REQUIRED

- (i) Filled in application form duly affixing one stamp sized photograph on the application form in the space provided and two identical stamp sized photographs with the applicant's name on the back side of the photograph.
- (ii) Attested copy of Annual Confidential Reports for the past four years.
- (iii) No Objection Certificate from HOD/District Collectors concerned (for persons posted in the Districts) as per Annexure – A.
- (iv) Office Order of initial appointment along with the joining report.
- (v) Office Order on promotion to the present post along with the joining report.
- (vi) Attested copy of Certificate of Identification/EPIC/Aadhar (for identification purpose).



4. TERMS & CONDITIONS

- i. Applicants should ensure that they are eligible and qualified on the date of application and their forms are complete in all respect. Application form should be supported by a copy of requisite documents as listed at Sl. No. 3 duly attested by the competent authority/officer. No Objection Certificate from the concerned authority as indicated at Sl. No. 3 should be submitted in original.
- ii. The filled in application form needs to be countersigned by the concerned District Collector in relation to applicants posted in the Districts and by Head of Office/Head of Department in relation to applicants posted in the LR & DMD Head Office, DILRMP Cell at Deorali and Land Records Office at Old Secretariat, Gangtok.
- iii. Incomplete application shall be summarily rejected. The Land Revenue & Disaster Management Department shall not make any correspondence to any applicant in this regard at personal level.
- iv. No application form submitted after 04:00 pm on 15/07/2021 will be accepted. Land Revenue & Disaster Management Department shall not be responsible for late receipt of application due to postal delay or otherwise.
- v. Applicants are advised to go through the Advertisement scrupulously and fill in the form accordingly.
- vi. No TA/DA is admissible for attending the examination.
- vii. Admission at all stages of examination for which applicants are admitted by the Land Revenue & Disaster Management Department will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that any applicant does not fulfil any of the eligibility conditions, their candidature for the post will be cancelled without notice.
- viii. A candidate is required to obtain the prescribed minimum qualifying marks in Paper-I. Likewise, he/she is also required to obtain the prescribed minimum score in ACR evaluation.
- ix. The Land Revenue & Disaster Management Department will not entertain any application for review or under R.T.I. till the entire process of recruitment is complete.
- x. The date of examination shall be announced subsequently.
