#### NOTICE

The Land Revenue & Disaster Management Department invites application in prescribed form from eligible candidates for filling up of 08 ( eight ) posts of Revenue Inspectors in level 11 of the pay matrix through Limited Departmental Promotion Examination.

#### CONDITIONS OF ELIGIBILITY:-

Complete application form supported by requisite documents should reach the office of the Secretary, Land Revenue & Disaster Management Department on or before 15/03/2020.

#### 1. SCHEME OF EXAMINATION

The examination for the post of Revenue Inspector will consist one paper :-

All questions except précis writing and report writing will be of "Multiple Choice Question" (MCQ) and carry 2 marks each. There shall be no negative marking.

The candidate securing minimum qualifying marks shall be considered for the next round of selection process, i.e A.C.R evaluation. Merit list will be drawn on the basis of cumulative score. Based on the number of vacancies available, corresponding number of candidates in the order of merit shall be declared as qualified.

The score of ACR evaluation will be determined as under:-

An aggregate of score for preceding four years will be taken as the final score.

- (iv) Revenue Administration.
- Land Acquisition (RIGHT TO FAIR COMPENSATION, TRANSPARENCY, LAND ACQUISITION, RESETTLEMENT & REHABILITATION ACT OF 2013).

#### 3. DOCUMENTS REQUIRED

- (i) Filled in application form duly affixing one stamp sized photograph on the application form in the space provided and two identical stamp sized photographs with the applicant's name on the back side of the photograph.
- Attested copy of Annual Confidential Report for the past four years.
- (iii) No Objection Certificate from the HOD/ District Collectors concerned (for persons posted in the districts) as per Annexure –A.
- (iv) Office Order on initial appointment along with joining report.
- Office Order for promotion to the present post along with joining report.
- (vi) Attested copy of Certificate of Identification, EPIC, Aadhar card (for identification purpose).

#### 4. TERMS AND CONDITIONS.

- (i) Applicants should ensure that they are eligible and qualified on the date of application and their forms are complete in all respects. Application forms should be supported by a copy of requisite documents as listed at SI No 3 duly attested by the competent authority/ officer. No Objection Certificate from the concerned authority as indicated at SI No 3 should be submitted in original.
- (ii) The filled in application forms duly countersigned by the concerned District Collector in respect of applicants posted in the districts and by the Head of Office/ Head of Department in respect to applicants posted in the Head Office/ Land Record Office/ D.I.L.R.M.P.
- (iii) Incomplete application shall be summarily rejected. The Land Revenue & Disaster Management Department shall not make any correspondence to any applicants in this regard at personal level.
- (iv) No application form submitted after 4:00 pm on 20/03/2020 will be accepted. Land Revenue & Disaster Management Department shall not be responsible for late receipt of application due to postal delay or otherwise.
- (v) Applicants are advised to go through the Advertisement scrupulously and fill in the form accordingly.
- (vi) No TA/DA is admissible for attending the examination.
- (vii) Admission at all stages of examination for which applicants are admitted in the Land Revenue & Disaster Management Department will be purely provisional and is subject to satisfying the prescribed eligibility condition. If, on verification, at any stage of the examination process, it us found that the applicant does not fulfill any of the eligibility conditions, their candidature for the post will be cancelled without notice.
- (viii) A candidate is required to obtain the prescribed minimum qualifying marks in Paper-I. Likewise, he/she is also required to obtain the prescribed minimum score in the ACR evaluation.
- (ix) The Land Revenue & Disaster Management Department will not entertain any application for review or under R.T.I Act 2005, till the entire process of recruitment is complete.
- (x) The date of examination shall be announced subsequently.
