**PRELIMINARY NOTIFICATION UNDER SECTION 11(1) OF RIGHT TO FAIR
COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND
RESETTLEMENT ACT, 2013 (ACT 30 OF 2013).**

Whereas, it appears to the Government that land is likely to be needed for a public purpose, namely for Construction of road at ADMS area near 327 Field Hospital under Chungthang Block by 86 RCC (GREF), BRO, Ministry of Defence, Government of India, in the blocks of Chungthang, District Mangan, North Sikkim. It is hereby notified that the several pieces of land comprising cadastral plots mentioned under the "Schedule of Properties" below and measuring more or less area of **0.2000 hectares** (Private Land) is likely to be needed for the aforesaid public purpose at public expense, within the aforesaid block of Chungthang, North Sikkim.
