**DECLARATION UNDER SECTION 19 OF RIGHT TO FAIR COMPENSATION AND
TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND
RESETTLEMENT ACT, 2013 (ACT 30 OF 2013).**

Whereas, vide Preliminary Notification No.61/LR&DMD/ACQ/GOS /34 dated 11/02/2025, Gazette Notification No.18 dated 14/02/2025 and Corrigendum No.67/LR&DMD/ACQ/GOS dated 04/04/2025, it was notified under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013) that the land described in the Schedule hereto thereafter referred to as the said land were required or likely to be required for the purpose namely for new alignment of Chungthang-Lachen Road at Chungthang and muck Disposal by Border Road Organization 86 RCC/758 BRFT(P) Swastik, Ministry of Defence, Government of India in the Revenue of Chungthang, North Sikkim based on the field reports submitted by Sub-Divisional Office, Chungthang.

And whereas, the preparation of the mandated Rehabilitation and Resettlement scheme shall not be applicable because there is no displacement of family/families due to the proposed acquisition.

And whereas, as per Section 19 (1) of Right to fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the appropriate Government is satisfied that the said lands are required for public purpose.

Now, therefore, it is hereby declared under the provision of Section 19(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the said lands are required for the aforementioned public purpose, on Chungthang-Lachen road in the block of Chungthang, Mangan District.
