**PRELIMINARY NOTIFICATION UNDER SECTION 11(1) OF RIGHT TO FAIR  
COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND  
RESETTLEMENT ACT, 2013 (ACT 30 OF 2013).**

Whereas, it appears to the Government that land is likely to be needed for a public purpose, namely for Construction/Improvement of EPC mode of existing road to NHDL specification with paved shoulder from Lachung to Shingba Rhododendron Wildlife Sanctuary from km 0.00 to km 5.245 on road Lachung-Yumthang-Yume Samdong Border Section (Kerang) (Part of NH-310A) at Lachung under PKG-V at Lachung Revenue Block in the State of Sikkim under project Swastik under 115 RCC/758 BRTF(P), Ministry of Defence, Government of India, in the blocks of Lachung, District Mangan, North Sikkim. It is hereby notified that the several pieces of land comprising cadastral plots mentioned under the "Schedule of Properties" below and measuring more or less area of **2.8739 hectares** (Private Land) and **1.4395 hectares** (Sikkim Sarkar) is likely to be needed for the aforesaid public purpose at public expense, within the aforesaid block of Lachung, North Sikkim.
