**DECLARATION UNDER SECTION 19 OF THE RIGHT TO BLABILITATION TAND AND
TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT,
2013 (ACT 30 OF 2013).**

Whereas, vide Preliminary Notification No. 952/LR&DMD/ACQ/GOS/22 Dated 04/10/2023 and Gazette No. 330 Dated:10/10/2023 and Corrigendum issued vide Notification No.60/LR&DMD/ACQ/GOS Dated:04/02/2025, it was notified under section 11(1) of the Right To Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013) that the land described in the Schedule hereto thereafter referred to the said land were required or likely to be acquired for the public purpose namely for the construction of road Reshi-Rongli-Kupup Road Ministry of Defence, Government of India in Padamchen Block under Rongli Sub Division, Pakyong District.

And whereas, the preparation of the mandated Rehabilitation Resettlement Scheme shall not be applicable because there is no displacement of family/families due to the proposed acquisition.

And whereas, as per Section 19(1) of Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013, the appropriate Government is satisfied that the said lands are required for public purpose.

Now, therefore, it is hereby declared under the provision of Section 19(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the said Lands are required for the aforementioned public purpose in the aforesaid revenue block Padamchen under Pakyong District.
