In the Notice Under Section 11(1) of RFCTLARR Act, 2013 (Act 30 of 2013) issued vide Notification No. 43/LR&DMD/ACQ/GOS dated: 16/07/2021 and published in Government Gazette No. 202 dated 17th August 2021 in relation to acquisition of land for Construction of Key Location Places in the blocks of Lachen, Lachung & Chungthang, North Sikkim by the Indian Army, Ministry of Defence, (Government of India) may be read as total area measuring more or less 102.3130 hectares instead of 102.7859 hectares.

DECLARATION UNDER SECTION 19 OF RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013 (ACT 30 OF 2013).

Whereas, vide preliminary notification No.43/LR&DMD/ACQ/GOS dated 16/07/2021 and Gazette No. 202/LR&DMD/ACQ/GOS dated:17/08/2021, it was notified under section 11 of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013) that the land described in the schedule hereto (thereafter referred to as the said land) were required or likely to be acquired for the public purpose namely for the purpose of construction of Key Location Places by Indian Army, Ministry of Defence (A Government of India), in the blocks of Lachen, Lachung and Chungthang, North Sikkim.

And whereas, vide letter No.113 & 114/DC/North dated: 11/11/2021 that the Sub Divisional Magistrate, Chungthang has initiated the prior consent process and land acquisition under the provision of section 12 of RFCTLARR Act, 2013.

And whereas, based on the field report submitted by Sub Division Office, Chungthang, the preparation of the mandated Rehabilitation and Resettlement Scheme shall be prepared by the Administrator and there is no displacement of family/families due to the proposed acquisition.

And whereas, as per Section 19 (I) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the appropriate Government is satisfied that the said lands are required for public purpose.

Now, therefore, it is hereby declared under the provision of Section 19(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the said land is required for public purpose, namely for the aforementioned purpose in the aforesaid Revenue Blocks of Lachen, Lachung & Chungthang, North Sikkim.

Report for the Rehabilitation and Resettlement Scheme u/s 16 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation & Resettlement Act 2013 in respect of Land Acquisition of 105.4545 Hectares of Land in Lachung, Lachen & Chungthang under Chungthang Revenue Circle for Key Location Point Construction under Ministry of Defence, Government of India. 102.7859 hectares of land notified for acquisition for Ministry of Defence in Lachung (73.9162 ha), Lachen (25.2677 ha) and Chungthang (3.602 ha) revenue blocks in Chungthang Subdivision of North Sikkim district has been under possession of the Army from the period starting from 1960s onwards.

A. Preface:

Preliminary Notification u/s 11 of RFCTLARR Act 2013 vide No: 43/LR&DMD/Accq/GOS Dated: 16/07/2021 land measuring 102.7859 located in Lachen, Lachung and Chungthang Revenue Blocks notified for Permanent Acquisition for Public Purpose as defined as KLP Construction by the Army, Ministry of Defence, GOI.

In the context of preparation of Rehabilitation and Resettlement Plan under section 16 of RFCTLARR Act 2013, the undersigned has been appointed as Administrator Vide No: 01/LR&DMD/Accq/GOS Dated 22/04/2022 to prepare Rehabilitation & Resettlement Scheme/Plan for affected families.

B. Details of Rehabilitation & Resettlement Package:

Based on the Field Survey and Report of Social Impact Studies following details of Rehabilitation and Resettlement Scheme/Package have been worked out:

Besides above cost for Rehabilitation & Resettlement Scheme the study team for Social Impact Assessment under its Social Impact Mitigation Plan has suggested Corpus Fund of Rs 4.00 Crores for addressing post acquisition access restrictions from the defence acquired lands at Kuyzoten and Bitch under Lachung Dzomsa. Further, resettlement grants of Rs 5.50 Lakhs to Mrs Suki Lachenpa whose house being used by the Army since 2003 and left in a dilapidated condition hence she is entitled for resettlement compensation excluding land compensation as her plot 863 is not proposed for acquisition.

Institutional Support fund of Rs 25 Lakhs has also been proposed under SIMP for Primary Health Centres and Primary Health Sub-Centres to strengthen equipment and infrastructural requirements in these centres.
