

CORRIGENDUM

In the preliminary notification, under section 11(1) of Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013) issued vide Notification No.23/LR&DMD/ACQ/GOS dated 05/12/2023 and published in Government Gazette No.506 dated 7th December 2023 in relation to acquisition of land for the construction/improvement of Singtam-Dikchu road from Km 10.00 to Km 32.70 by GREF at Singbel, Dung Dung, Tumin, Patuk, Rakdong, Raleykhesey, Samdong, Kambal and Tintek Blocks under Gangtok District may be read as total area approximately 5.6911 hectares of private land instead of 4.9002 hectares and approximately 1.7193 hectares of Government land instead of 1.7034 hectares.

1. Tumin Block

Plot nos. 311/P, 287/P, 286/P, 972/3908, 1021/4010/P, 1021/P are included. Hence, now the total area of private land under Tumin Block may be read as 0.9393 hectares instead of 0.7029 hectares.

2. Patuk Block

Plot nos. 1673/1697, 164/1673, 1345/1777, 731/1669, 165/P, 740/1709, 123/P, 124/P, 1673/1701, 1813/1824/P, 136/1820/P, 159/P, 1671/1698, 1673/1699 are included. Hence, now the total area of private land under Patuk Block may be read as 1.4905 hectares instead of 1.2455 hectares.

3. Kambal Block

Plot nos. 311/1063/P is included. Hence, now the total area of private land under Kambal Block may be read as 1.2563 hectares instead of 1.2200 hectares.

4. Tintek Block

Plot nos. 1846/2063, 321/1843/P, 321/P, 1846/1867, 320/1857/P, 272/1841/P, 325/P, 320/1599/P, 321/1845, 156/1882, 156/P, 154/P, 156/2277/P, 320/1846/P are included. Hence, now the total area of Private land under Tintek Block may be read as 0.2412 hectares instead of 0.0700 hectares.

Plot no. 34/P is included. Hence, now the total area of Sikkim Sarkar under Tintek Block may be read as 0.0159 hectares instead of 0.0140 hectares.

5. Rakdong Block

Plot nos. 604/P, 604/3303, 605/3304, 588/3498, 36/P/A, 36/P/B, 36/P/C, 36/P/D are included. Hence, now the total area of Private land under Rakdong Block may be read as 0.3450 hectares instead of 0.2730 hectares.

Plot nos. 571/P, 606/P are included. Hence, now the total area of Sikkim Sarkar under Rakdong Block may be read as 0.4551 hectares instead of 0.4411 hectares.

6. Samdong Block

Plot nos. 390/2034, 391/2035 is included. Hence, now the total area of Private land under Samdong Block may be read as 0.6348 hectares instead of 0.6178 hectares.

7. Raleykhesey Block

Plot nos. 507/P, 508/P is included. Hence, now the total area of Private land under Raley Khesey Block may be read as 0.0970 hectares instead of 0.0770 hectares.
